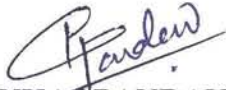

3. There are no Investors Complaints pending as on 30th May, 2022.
4. The figures of the current half year/year ended 31st March, 2022 and previous half year ended 30th September, 2021 are the audited figures.
5. The Company is engaged in the Business of Trading of Diamonds, Precious Metals, Stones & Jewellery. Hence, there is no separate reporting segment in terms of Accounting Standard 17.
6. The Company has not adopted the Indian Accounting Standards (IND AS) in terms of Exemptions available to the Companies Listed with SME Exchange.
7. The above Cash flow statement has been prepared under the "Indirect Method" as set out in Accounting Standard-3, "Cash Flow Statements" issued under the Companies (Accounting Standard) Rules, 2006.
8. The Figures for the previous half year / year have been regrouped/reclassified, wherever necessary to confirm to current period/year classification.
9. In May, 2022, The Company has completed the SME IPO of 4,38,000 Equity Shares of the Company of face value of Rs. 10/- each, issued at a price of Rs. 50/- per share (including a share premium of Rs. 40/- per equity share). The issue comprised of fresh issue of 4,38,000 equity shares aggregating to Rs. 219.00 Lakhs. The equity shares of the Company were listed on SME Platform of BSE Limited on 6th May, 2022.
